## Conditions for installation of a dishwasher

- § 1 Application for the installation must be in writing.
- § 2 The tenant is obliged to maintain the dishwasher so that it is kept in a proper condition.
- § 3 The permission for installing the dishwasher is personal and can not be transferred to anyone including family members who live at home or co-tenants. The permit includes only the dishwasher model on page 1. Installation of other dishwashers can not be done unless special permission is obtained from Kollegiekontoret.
- § 4 All costs of installing and dismantling, including any expenses for the restoration of the landlord's property/building, must be paid for by the tenant.
- § 5 Installation, removal and re-establishment work must be carried out by professionals who are employed by a taxable business. The landlord must, before the work is started, have approved the extent of the work, including the location of the dishwasher in the kitchen.

The work must be carried out in accordance with the instructions of Kollegiekontoret, including requirements for the installation of a non-returnable valve and aqua stop. The dishwasher must also be placed on a plastic tray.

- § 6 In the event that the dishwasher should give rise to damages to the property/building drainage installations, the landlord has the right to require the dishwasher to be removed. Cost of removal is paid for by the tenant.
- § 7 The dishwasher must be removed by the tenant upon the end the lease. Costs are paid for by the tenant.
- § 8 If the tenant's permission to install the dishwasher is revoked as a result of the tenant's breach of the conditions for the permit, the landlord is entitled to remove the dishwasher immediately if the tenant has not removed the dishwasher within 8 days' notice.
- § 9 If Kollegiekontoret finds an illegally installed dishwasher for which no permit has been granted, or it is installed in a location other than designated by Kollegiekontoret, the tenant will be

informed that the dishwasher is unlawfully installed and it must be removed before a fixed time.

If the tenant neither removes the dishwasher, nor applies for installation and has it approved according to the applicable rules, a customary house rules case will begin.
